STATE OF SOUTH CAROLINA AMENDMENT TO MASTER DEED OF LINKS CLUBHOUSE VILLAS HORIZONTAL PROPERTY REGIME **COUNTY OF CHARLESTON**)

THIS AMENDMENT to the Master Deed of Links Clubhouse Villas Horizontal Property Regime ("Amendment") is made by Links Clubhouse Villas Council of Co-Owners, Inc. ("Association") this 2 \ day of December, 2020.

WITNESSETH:

WHEREAS, the Master Deed of Links Clubhouse Villas Horizontal Property Regime ("Master Deed") was recorded in the Register's Office for Charleston County, South Carolina ("ROD") on July 30, 1990, in Book J-195, at Page 158; and

WHEREAS Article XII, Section 1 of the Master Deed allows an amendment to the Master Deed upon approval by at least two-thirds (%) of the Percentage Interests then existing in accordance with the procedure set forth in the Bylaws which are attached as Exhibit "F" to the Master Deed ("Bylaws"); and

WHEREAS, at least two-thirds (3/3) of the Percentage Interests then existing, in accordance with the procedure set forth in the Bylaws, approved an amendment to the Master Deed as hereinafter more specifically set forth.

NOW, THEREFORE, upon the approval of at least two-thirds (3/3) of the Percentage Interests then existing, in accordance with the procedures set forth in the Bylaws, the Master Deed is amended as follows, to-wit:

By adding Section 11 to Article VII of the Master Deed as follows:

Section 11. Capital Contribution. Every Purchaser of an Apartment at Links Clubhouse Villas Horizontal Property Regime shall pay to the Association, at the time of Purchase of such Apartment, a capital contribution fee equal to one-half (1/2) of One (1%) percent of the Purchase Price of such Apartment. Failure by the purchaser to pay the capital contribution fee shall be equivalent to the nonpayment of assessments of Common Expenses and Association may exercise any and all remedies set forth in the Master Deed and Bylaws of Links Clubhouse Villas Horizontal Property Regime to collect such capital contribution fee including, but not limited to, the recovery of reasonable attorney fees and costs. This Capital Contribution shall be effective January 1, 2021.

EXCEPT AS AMENDED HEREIN, all other terms and conditions of the Master Deed, as it may be amended from time to time, shall remain in full force and effect.


